Following receipt of your request, searches were conducted within Leicestershire Police to locate information relevant to your request.

Your request for information has now been considered and the information asked for is as follows: -

Please see attached the 3 job descriptions for the CSI roles employed by Leicestershire Police on the attachment to the Email .

I have been advised that the CSIs do their own photography therefore there isn't a separate role for this and we don't have any Mappers.

The salaries are as follows:

Tier 1 - Salary = Scale 5 = £23,235 - £25,380 Tier 2 - Salary = SO2 = £31,875 - £33,732 Tier 3 - Salary = PO34 = £34,716 - £37,440

All posts receive 14% shift allowance, on call allowance and weekend working allowance

The CSI roles are managed regionally by Derbyshire who would have the detail on training and supervisor grades. Although the CSI tier 3 is the most senior in Leicestershire Police and they do manage the other tiers.

Leicestershire Police provides you the right to ask for a re-examination of your request under its review procedure. Letters should be addressed to Information Manager, Corporate Services Department at the above address. If you decide to request such a review and having followed the Force's full process you are still dissatisfied, then you have the right to direct your comments to the Information Commissioner who will give it consideration.
