I write further to your request for information received 20/11/2020.

I note you seek access to the following information:

I'm writing to you under the Freedom of Information Act to request data held by your constabulary on ketamine seizures in the past three years. (2020, 2019, 2018).

Whether this involves the total amount of ketamine seizures, quantities or ketamine related drug offences resulting in arrests - whatever stats you have.

Also any copies of any reports or memos which mention ketamine seizures and arrests.

While this is a wide breadth as I'm asking for what you have (in case I am too specific and you say the information is not held or would involve heavily searching easy case file etc), should you have so much ketamine related info that you deem this FOI to take too long under section 14 - I am most interested in the total amount of ketamine seizures in the past 3 years and whether they have increased, to narrow it down.

Following receipt of your request, searches were conducted within Leicestershire Police to locate information relevant to your request.

Your request for information has now been considered and the information asked for is as follows: -
